What is the Office of Justice Programs?

- The Office of Justice Programs (OJP) provides grant funding, training, research, and statistics to the criminal justice community.
- OJP is one of three grant-making components of the Department of Justice along with the **Office on Violence Against Women (OVW)** and the **Office of Community Oriented Policing Services (COPS)**.

Funding to reduce recidivism and improve outcomes for youth and adults leaving detention and incarceration to return to their communities.



National Reentry Resource Center



Corrections and Community Engagement Technical Assistance Center

AIR operates the Corrections and Community Engagement Technical Assistance Center (CCETAC). CCETAC's primary mission is to provide training and technical assistance to a segment of Second Chance Act grantees.

CCETAC coaches work closely with grantees to:

- Finalize action plans.

Smart Reentry: Expanding Jail Programs and Services

Purpose

- Improve reentry programs and services for people in and returning home from jails.
- Support units of local government and federally recognized Indian tribal governments.
- Develop and provide innovative, evidence-based reentry programming and services that address the needs of individuals returning to the community and reduce recidivism.

Eligible Applicants

City or township, county, Native American tribal (recognized), and special district governments.

- An applicant entity may submit more than one application.
- BJA will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant.
- BJA may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years.



Goal & Objectives

Goal

Improve jail reentry programs and services for individuals who are incarcerated in jails and upon their return to the community.



Objectives

Articulate and implement a robust vision for jail reentry programs and services with intensive transitional supports, including:

- Individualized case planning
- Evidence-based interventions
- Increased collaboration with providers and other reentry stakeholders

Deliverables

- Deliverable 1: Task force review.
- Deliverable 2: Assessment results and action plan.
- Deliverable 3: Preliminary process evaluation reflecting system improvements due at 30 months.
- Deliverable 4: Preliminary outcome and/or impact evaluation due at 36 months.
- Deliverable 5: Final process evaluations due at grant closeout and 90 days after the end of the 48-month grant period.

Grant Award Information

Number of awards: 5

Maximum award amount: \$1,000,000

Period of performance starts: 10/1/2023

Grant cycle: 48 months

Total amount to be awarded: \$5,000,000

DOJ Grants Financial Guide

- Compiles a variety of laws, rules, and regulations that affect the financial and administrative management of DOJ awards.
- Serves as a starting point for all award recipients and subrecipients of DOJ grants and cooperative agreements in ensuring the effective day-to-day management of awards.

Unallowable Uses of Award Funds

- Pre-agreement costs (also known as “pre-award costs”)
- Limitation on use of award funds for employee compensation: waiver
- Prior approval, planning, and reporting of conference/meeting/training costs
- Costs associated with language assistance (if applicable)

Second Chance Act Mandatory Requirements

1. Reentry strategic plan
2. Detailed reentry implementation schedule and sustainability plan
3. Reentry task force
4. Independent evaluation
5. Evidence of collaboration with state and local government agencies
6. Consideration of the role of state corrections departments, parole and probation agencies, and local jail corrections systems in ensuring successful reentry
7. Chief executive officer support
8. Understanding of evidence-based methods and outcome measures
9. Description of how the program or strategy could be scaled up or broadly replicated if demonstrated to be effective
10. A plan to analyze the statutory, regulatory, rules-based, and practice-based hurdles to reentry

Memorandums of Understanding and Other Documents

- Include for each named partner, a signed memorandum of understanding (MOU), letter of intent, or subcontract that confirms agreement to support the project through commitments of staff time, space, services, or other project needs.
- For applications submitted from two or more entities, submit signed MOUs or letters of intent that describe how the agencies will work together to meet the project requirements.
- Subcontracts, MOUs, or letters of intent should be submitted as one separate attachment to the application.

Documentation of Advancing DOJ Priorities

- Promotes racial equity
- Increases access to justice
- Supports crime victims and individuals impacted by the justice system
- Strengthens community safety and protects the public from crime and evolving threats
- Builds trust between law enforcement and the community



Priority Areas

Advancing Racial Equity and Support for Underserved Communities Through the Federal Government. In support of this Executive Order, OJP will provide priority consideration to:

- a) Proposed project(s) designed to **promote racial equity** and the **removal of barriers** to justice access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.
- b) Applications that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they identify as a culturally specific organization.

Tribal Authorizing Resolution

- If applicable, submit the Tribal Authorizing Resolution by uploading it as an attachment in JustGrants.
- See the [OJP Grant Application Resource Guide](#) for information on tribal authorizing resolutions.

Plan for Data Collection for Performance Measures

Describe how the data required for this solicitation's performance measures will be collected, including the system(s) used and the person(s) responsible.

Describe whether and how other relevant performance metrics will be documented, monitored, and evaluated.



Budget

- Requires a 50% match (50% must be cash, and the remaining 50% may be in kind).
- The estimates must provide a breakdown of all costs and must adhere to the federal per diem.
- The grantee can access up to \$75,000 of the grant award during the planning phase and will be required to participate in technical assistance and to complete and submit an action plan to guide implementation.

Before You Apply

Registration

Register with the **System for Award Management (SAM)**.

- You must renew and validate your registration every 12 months.
- If you do not renew your SAM registration, it will expire.
- An expired registration can delay or prevent application submission in Grants.gov and JustGrants.
- Registration and renewal can take up to 10 business days to complete.

Two-Step Application Process

Step 1 (Grants.gov)

- After registering with SAM, submit the **SF-424** and **SF-LLL** in Grants.gov at <https://www.grants.gov/web/grants/register.html> as early as possible, but no later than 48 hours before the Grants.gov deadline.
- The Grants.gov deadline is June 5, 2023, at 8:59 p.m. ET.

Step 2 (JustGrants)

- Submit the full application, including attachments, at <https://justicegrants.usdoj.gov/>.
- The JustGrants deadline is June 12, 2023, at 8:59 p.m. ET.

- ✓ Identify the forms needed to submit an application.

- ✓ Complete an application, including certifying the information.
- ✓ Submit the application.

Review Criteria

Selection Criteria	Weight
Statement of problem/Description of the issue	25%
Project design and implementation	35%
Capabilities and competencies	15%
Plan for collecting data on performance measures	5%
Budget	5%
Impact/Outcomes, Evaluation, Sustainability	15%
