# Transcript for "Screening and Q&A of 'Video Shorts' on Timely Evaluation Topics (4/30/21)

## Slide 1

Good afternoon and welcome to this webinar from the Evaluation and Sustainability Training and Technical Assistance team. I am Christine Lindquist from RTI International and I direct this project.

### Slide 2

Just to give you a little background, this is a BJA-funded TTA project led by RTI, in partnership with the Center for Court Innovation. We provide intensive TTA to a subset of Second Chance Act grantees to help them conduct more rigorous evaluations that lead to data-driven program improvement and demonstrated impact and that support programs' long-term sustainability. In addition, we produce evaluation and sustainability products that are available to all SCA grantees who are looking for tools to help them more rigorously evaluate and sustain their programs.

## Slide 3

Here are examples of some of the products our team has produced and that are available on the NRRC website. Our products are focused on helping reentry programs rigorously assess the impact of their programs, convey the impact as effectively as possible, and, ultimately, sustain their programs. Our products include archived webinars, video shorts like the ones you will see today, infographics, fact sheets, and full-length resource briefs.

Many practitioners are open to and interested in the possibility of evaluating their reentry program but are unclear on initial steps and considerations for performing this type of investigation.

The next video you are about to see will provide an overview of 5 key things to consider before getting an evaluation of your reentry program off the ground.

The content for the third video, which is on using evaluation data to assess and enhance cultural responsiveness, was developed by Lama Hassoun Ayoub from CCI. Lama, I will turn it over to you.

We know that having culturally responsive programs can help ensure that clients of all backgrounds are engaged and may help increase the likelihood that they are successful.

This video will outline how you can assess the cultural responsiveness of your program and work to enhance it.
