## **SRR is a Unique Grant Program**

#### HOW THE STATEWIDE RECIDIVISM-REDUCTION **PROGRAM CAN MAKE A DIFFERENCE IN YOUR STATE**

C tate policymakers everywhere are calling on their corrections directors to work with other criminal justice leaders and community-based service providers to reduce reincasceration and rearrest rates for adults leaving prison. #### GRANTS AND TECHNICAL ASSISTANCE

SRR grantees engage in planning and States that receive SRR grants are encouraged to adhere to the following principles:

Focus on the individuals who are most likely to recidivate based on risk/need assessments and sate that information to determine the type and intensity of programming and supervision that should be provided them.

Provide appropriate services and treatment that draw on evidence-based approaches and ensure high-quality service delivery.

O Use supervision policies and practices that address criminogenic risk/need and balance the goals of promoting accountability and providing needed treatment and reentry

implementation processes: First, states receive grants to participate in a competitive planning process. They being together stakeholdern, set measurable recidivism reduction goals, and develop comprehensive, data-driven plans to achieve those goals.

1 Then, states that put forward the strongest plan are awarded \$1 million for implementation, with the potential for supplemental awards to total \$3 million over three years.<sup>1</sup> BJA envisions that these states will act as ornters of excellence that can stand as national models for statewide recidivism reduction while achieving public safety goals.




## Map of FY14-16 SRR Grantees


- 1. Establishing a collaborative Decision-Making Body and Planning Process



## **SRR Planning Process: Planning Guide**



### **Technical Assistance: Planning Guide**

- Work with team of stakeholders and TA provider to complete each section of the Planning Guide in phases
- Fill out exercises prior to NRRC monthly calls with your TA provider
  - Send to TA provider exercises prior to calls
  - Discuss exercises on calls
  - Update the exercises as changes occur
- TA to inform exercises and plans



# Establish Task Force and Planning Process

- Review of vision, mission, and goals
- Relationship with other agencies and grants
- Environmental scan
- Establish planning team, work groups, engage partners and stakeholders
  - Team members and support for project
  - Key partners, service providers, and stakeholders
  - Need for additional outreach



### **Analyze Recidivism Data and Set Goals**

- Define and measure the statewide recidivism rate
- Understand key drivers of the recidivism rate
- Identify a target population for interventions and policy changes based upon those key drivers
- Set recidivism reduction goals for the target population and statewide recidivism rates.




### **Review Policies, Practices, and Programs**

Use Recidivism Reduction Checklists to assess current reentry policies and practices related to three goals:

- Use risk and needs assessments to inform resourceallocation decisions and individual case responses
- Establish programs and practices that reduce recidivism and ensure they are implemented with fidelity
- Implement community supervision policies and practices that promote successful reentry



- Systemic capacity-building
- Expanding evidence-based interventions







## Nevada's Plan

#### <u>Nevada Risk Assessment System (NRAS – Modeled after ORAS)</u>

- NDOC in partnership is in the process of validating the NRAS for Nevada's population
- Currently identifying and addressing criminogenic needs of our offender population for program development and placement
- Case Planning processes will begin in year two of the SRR Grant based on limited case management training

#### Workforce Development

- Partnering with Parole and Probation to implement NRAS in Parole.
- EPICS training conducted in conjunction with Parole and Community Partners .
- Expanding base of Community and state agency partners
- Providing Continuity of Care, Programming, Medicaid Eligibility
- Training and adopting evidence-based practices for re-entry (i.e. MRT)



## Nevada's Plan

#### **Quality Improvement**

- Staff Training that requires competency testing not just attendance
- Qualitative and Quantitative Audit Instruments are currently being developed
- Conducting a review of all Evidence-Based Programs to provide a smaller number of programs with efficiency and fidelity, rather than a larger number of ineffective programs
